

STUDIO MEMBERSHIP AGREEMENT

Why You're Reading This Document: The following Studio Membership Agreement (the “**Agreement**”) will clearly communicate our expectations of having you as part of our community. If you have any questions, please let us know, as we want to make sure we are all on the same page moving forward. You agree to be bound by the following conditions in exchange for membership access to Zokawa’s classes and studio. 1.

Parties. This Agreement is made between Zokawa: The Center of Happiness LLC, a limited liability company operating out of the State of Indiana (“**Zokawa**”, “**we**”, “**our**”, and “**us**”), and you, the undersigned (electronically, or in person) or person who has clicked “I Agree” to this Agreement (“**you**” and “**your**”). 2. **Services.** We promise to provide you with access to our studio and the full use of our facilities, as well as access to our regularly scheduled classes (either online or in-person) at Zokawa (the “**Membership**”) according to the terms outlined in Schedule “A” Memberships below.

I am aware that to terminate this agreement, I must notify the studio before the end of my term. Otherwise, my membership will continue to auto-renew as a monthly recurring membership at the rate of _____ after the completion of the initial term, in perpetuity unless cancelled. Any payments made will not be refunded.

If I would like to cancel this agreement within my agreed-upon term, I understand that Zokawa allows a one-time buyout cancellation fee for termed memberships, whereas a fee of 50% of the remaining term value of the contract must be paid to cancel the membership agreement.

I understand the **Membership Freeze** policy, which allows me to suspend my membership in 30-day increments and for up to 3 months per calendar year with seven days' notice, and that I am still liable to complete my membership term expectations.

THE FINE PRINT

Terms: This Agreement is binding upon your initial Membership payment and will last for the time specified in Schedule "A" Memberships above.

You may decide to renew the Term of this Agreement as many times as you would like.

Cancellation: To terminate or change this Agreement, please contact Zokawa by emailing us at zokawamuncie@gmail.com or contacting the studio in person.

In the Case of Moving: If, during the original term of this contract you relocate more than a 20-mile radius from Zokawa, you may cancel this agreement by providing written notice. No cancellation fee will be charged.

In the Case of Disability/Death: If you die or become permanently disabled, you or your estate may cancel this contract by contacting us. Any pre-paid dues will be refunded, and no cancellation fee will be charged.

Upgrade/Downgrade: Zokawa allows you to upgrade or downgrade your membership within your term to suit your utilization needs best. You are still obligated to carry out the term length (i.e. 3 months or 12 months) if you upgrade or downgrade. No fee is charged for these changes.

Refunds: Payments made will not be refunded. In the case of membership cancellation, 50% of the remaining term will be charged as the cancellation fee.

Membership Freeze: To freeze your membership and autopay please email zokawamuncie@gmail.com and provide at least 7 days' notice prior to the autopay date when you wish to freeze the membership. If you have a term membership (i.e. 3- months, etc.) or monthly recurring membership you may freeze time on the membership for up to 3 months of the calendar year in 30-day increments. Freezing your membership does not cancel your membership payments for the commitment term. You do not pay during the freeze period. You are still liable for your original payment and term length obligations. Once you resume any usage of Zokawa, the freeze will terminate.

Payment Failure: In the event that your Payment fails, your Membership access will be temporarily suspended until we receive your Payment.

Our Commitment to You: Through your Membership, Zokawa is committed to providing you with the opportunity and support to create positive change in yourself and others through the regular practice of yoga and self- care. Zokawa cannot guarantee any particular success from participating in our classes or from our Membership. We promise to provide you with the opportunity, classes taught by excellent teachers, and support to achieve your goals, but any success and results ultimately depends on your commitment.

Code of Conduct: You agree to be mindful and respectful during the classes and duration of your Membership. This includes respecting other members of Zokawa in their fitness journey and taking care when using the facilities and studio space. You also agree to comply with our studio protocol, policies and guidelines, as updated from time to time on our website or posted on-site.

Waiver: Before your Membership can begin, you must sign our Waiver Agreement form. Please read it and make sure you understand it. You need to sign that form as well as this Agreement so that we can be absolutely sure you understand and agree to it. (If you have already signed a waiver on your first visit, you do not need to sign it again.)

Media Release: We think you're incredible and would love to show you off! By being a member at our studio and through your Membership, you agree to grant us the irrevocable right to use

your image, likeness, photographs, video content, audio recordings of you captured in our studio or that you share with us online (via your own or others posting of you) as part of our online streaming, marketing and sales throughout the world and in perpetuity. You also release us from all claims you may have relating to the use mentioned in this section. Please let us know If you ever want us to stop using an image of you.
